ABOUT CRSP

The Court Referral Community Service Program (CRCSP) is a program that is grant funded through Douglas County. The purpose of the program is to benefit the community that has been harmed by an offender's crime, as well as the offender. Judges order offenders to complete community service hours and CRCSP refers them to agencies for completion of the ordered hours.

WHY CRCSP



CRCSP eliminates the need for probation officers to spend time referring clients to agencies and having to verify service hours which promotes efficiency. We refer clients to agencies, verify the hours directly with agencies, and report back to the officers.



CRCSP assists approximately 300 clients annually. With each client serving an average of 75 hours each, this represents over 2,500 service hours for our community.



Justice involvement, lack of career path and lack of support affect a clients success. This program helps remove barriers for clients; which can reduce recidivism, probation violations, and possible jail time.

CRCSP currently has relationships with many agencies across the community. United Way of the Midlands places all misdemeanor and felony offenses.

Transportation Assistance

We are now also offering transportation to and from agency sites, through Lyft, for those who have legitimate transportation needs so they can complete their service hours.

ABOUT OWP

The Offender Work Program (OWP) is a program administered by the Douglas County Courts. The program allows an individual to receive \$150 credit for every 8 hours of community service performed for a non-profit agency. You do not need to work a consecutive 8 hours, but your hours must be completed within the alloted time found in the table below. A minimum of 8 hours must be worked regardless of the fine amount.

Work is available at a variety of locations and on varying days of the week including weekends. OWP staff will assign participants to work locations based on schedule availability, transportation needs and best fit for participant skills.
